Our Commitment

Vibrantz Technologies Inc. ("Vibrantz") depends on its stakeholders to maintain a business environment of integrity and respect. The ongoing success of Vibrantz is dependent upon conducting business with integrity and in full compliance with regulations, legislation and our own corporate management policies and procedures ("Vibrantz Standards"). The Vibrantz Ethics Hotline is designed to allow you to confidentiality report any matters that you believe may be in violation of Vibrantz Standards.

Reporting your concerns is an important part of maintaining our culture of compliance and respect. While we encourage the reporting of issues directly to individuals within the Company, there may be times when a person is not comfortable doing so. Disclosing your identity can help facilitate questions and, in some circumstances, may protect your individual legal rights. Retaliation against individuals who report in good faith potential ethical and legal misconduct is prohibited. Vibrantz will seek to maintain the confidentiality of your identity and personal information, limiting disclosure to circumstances as necessary and appropriate.

Any reports provided through the Ethics Hotline portal will be sent to the Vibrantz Legal Department. Reports will be reviewed and investigated and corrective or disciplinary action for violations will be taken as appropriate. Certain misconduct, if required, may be reported to the appropriate government authorities.
