A MESSAGE FROM VIBRANTZ CEO MICHAEL KING

As we publish our 2025 CSR report, I want to start by recognizing the work reflected in these pages and the dedication of our teams around the world.

The progress in this report highlights focused effort across Vibrantz during a year that required resilience, discipline and a continued commitment to doing things the right way.

Since stepping into the CEO role in November 2025, one thing has become clear to me: this team cares deeply about responsible operations, serving customers and making a meaningful impact in the communities where we operate.

At Vibrantz, corporate social responsibility is not separate from how we run the business. It starts with safety and responsible operations. It includes how we support our people, reduce our environmental impact and show up in our communities. Put simply, doing the right thing and running the business the right way go hand in hand. Our CSR program continues to be guided by four core commitments:

- **Ethically centered:** We maintain a strong commitment to the safety of our people and operations. Operating responsibly and ethically is the baseline for how we do business around the world. In 2025, Vibrantz reduced total recordable incidents by more than 50% compared with the prior year, including a 63% improvement in total recordable incident rate.
- **Socially Connected:** We are committed to supporting our people and making a positive impact in the communities where we operate. In 2025, participation in our Vibrantz in Action program reached 66%, exceeding our 60% goal.
- **Environmentally responsible:** We are continuing to improve how we operate and reduce our environmental impact. In 2025, we received an EcoVadis Committed badge, an important recognition that reflects progress across the business.

- **Financially Disciplined:** We are focused on making disciplined decisions that support long-term performance. By investing thoughtfully in our facilities, systems and workforce, we are building the consistency, resilience and execution needed to succeed over time.

We are continuing to move forward on our CSR goals. This report is intended to provide an update on the progress we have made and key developments since our 2024 CSR report. For a broader view of our historical disclosures and metrics, please refer to the 2024 report. We will share a more comprehensive update in 2027 based on our 2026 data.

We know this work is ongoing. As we look ahead, we will continue to focus on operating responsibly and making steady progress in the areas that matter most. I am confident in the path ahead and in the team driving this work forward.

I want to thank our employees, customers and communities for their continued support. We remain committed to responsible operations, disciplined execution and creating long-term value for all of our stakeholders.

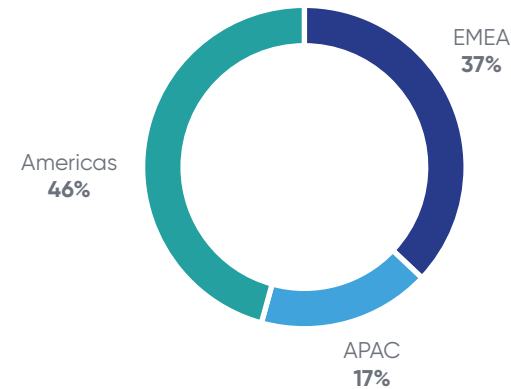

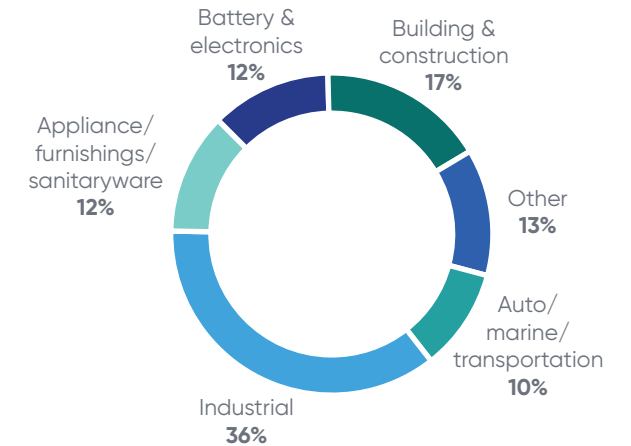

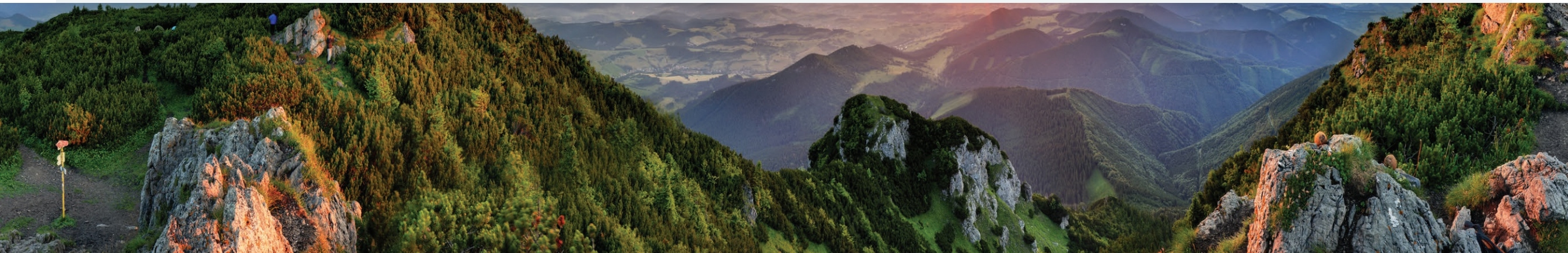
